
SUPPLEMENTARY ELECTORAL REGULATIONS 2023

The Election Committee for the 2023 elections consist of:

- Mats Vandemeulebroucke
- Stijn Smeets
- Anton Van Lieshout

They were elected to the Electoral Committee 2023 as Chairman, Vice-Chairman and Secretary. These persons were voted as the Electoral Committee 2023 in the General Assembly on 18 November 2023.

Furthermore, the following names are used:

- Industria for Student Association Industria vzw
- KC23 for Election Committee 2023
- Fakbar for De Fakbar vzw (better known as *Recup*)

In view of Art 90 §1, the following rules are added to the Electoral Rules by the KC23. These rules are supplementary to Art 76 to Art 146 and are valid for the 2023 elections. However, these rules follow the provisions of the Statutes and Internal Regulations of Industria, as laid down on 27 April 2022, the date of the last amendment

1. In communication with the KC23, titles are provided for. Communication and titles are limited to activities and conversations about the elections and election-related topics. This rule applies to both serious and fun teams. The titles or forms of address that are used during the elections are as follows
 - Mats Vandemeulebroucke: “Weledelzeergeleerde voorzitter”
 - Stijn Smeets: “Weledelgestrenge ondervoorzitter”
 - Anton Van Lieshout: “Weledelgeleerde secretaris”
 - The full KC23: “Weledelgeschoolde Kiescomité”
2. All official communications with the Neutral Committee should be by e-mail to kiescomite@industria.be or kc@industria.be.
3. Every team, both serious and fun teams, are forbidden to make deals in the name of Studentenvereniging Industria vzw, Industria vzw or Industria. It is also forbidden to make deals that affect our union in the short or long term.
4. §1. A fun team is recognised by the KC23 if they organise at least one activity approved by the KC23.

§2. Industria's maximum contribution per fun team will be determined based on the number of registrations on the registration deadline. This amount will be reimbursed before May 31, 2023
5. The fun team(s) will receive sponsorship if and only if they submit an account or a number of account to the KC23. The total amount of the account(s) must correspond to the amount made available by Industria, within a margin of €5 (FIVE EURO).

6. §1. It is strictly forbidden to contact companies before having received a list of "companies not to contact". This list must be requested by each team via an official mail to kc@industria.be. The list is flexible and can be modified. Any change will be communicated by the KC23.

§2. If a team nevertheless contacts a company that is on this list without the explicit, written consent of the KC23, the team may be forced to end its cooperation with this company.

7. In addition to Art 99 of the Internal Regulations of Industria, an exception is made that serious teams may mention the association, KU Leuven campus Group T Leuven, Faculty of Industrial Engineering KU Leuven or KU Leuven when contacting companies, if the serious teams hand over a partner file in an official mail to kc@industria.be before contacting companies. KC23 should also always be in Bcc in mails to companies if the team explicitly mentions the association.
8. Each meeting of a team (serious and fun team) within the buildings of KU Leuven Campus Group T must be announced to the KC23 at least one day in advance. An emergency meeting cannot take place in the KU Leuven Campus Group T buildings.
9. Each team (serious and fun team) must keep an open accounting. This means that the accounts must be available for inspection by the KC23 at all times. These accounts must be digitally available to the KC23 at the latest two hours after request.
10. Phoning with official KU Leuven Campus Group T telephones is strictly forbidden in rooms GT 01.4.01/1, GT 91.P1.13 and GT 92.P2.06. These are the Industria room, the Kursusdienst and the support room, respectively. Any other telephone calls with such devices must be reported to the KC23.
11. Serious teams should be present in full at the transfer cantus. All members of a serious team must come dressed as something that starts with the same letter as their first name. Penalties may be imposed by KC23 for any member not attending or not dressed correctly.
12. §1. A location request can be prepared by any serious team but must be submitted by the KC23. In the event of a conflict, the KC23 will decide who will have priority. No further discussion will be possible on this.
- §2. The chosen location should be shared by the KC23 to all teams, both serious teams and fun teams, regardless of the origin of the request.
13. In addition to Art 145 of the internal rules of Industria, depending on the corona measures in force, an appropriate activity will be provided for the counting of the votes. The candidate-praeses and candidate-vice-praeses of each serious team and fun team must be present at this activity.
14. §1. On activities of both serious teams and fun teams selling foods or drinks, the products are always first offered free of charge to the entire KC23. After approval of the KC23, the activity may proceed.
- §2. Members of the KC23 may participate in all activities organised by the team(s) free of charge.
15. Each team (serious and not serious) should provide an extra item of their textiles, this if the team

provides textiles for its members. The extra item will be paid for by KC23 and will serve for the archives of Industria.

16. Each member of each team (serious and not serious) should forward, in an email to kc@industria.be, their motivation for why they want to participate in Industria in the form of a poem.
17. Each team (serious and not serious) must fill the shifts, imposed by KC23, that come with the campaign day. If this is not done, KC23 may impose sanctions.
18. As a clarification/expansion of the electoral rules:
 - As an extension of Article 128 of Industria's Internal Regulations, online activities of Industria are also considered to be partially neutral territory.
 - There should be no material from each team (serious and fun team) on partially neutral ground.
 - No passive campaigning is allowed until the passive week on partly neutral ground.
19. Failure to meet a deadline will be punished by the KC23. The penalty will be decided by the Election Committee. Teams must respect the following deadlines:
 - 4 February 2023: First registration of serious teams.
 - 4 March 2023: Second registration of serious teams.
 - 19 March 2023: Dates and locations for all activities of all teams.
 - 1 April 2023: Finished script for all activities of all teams.
 - 4 April 2023: Registration for fun teams.
 - 10 April 2023: Application for disc IV for the serious teams.
 - 17 April 2023: Application for discs II and III for the serious teams.
 - 30 April 2023: Final list with members of the serious teams.
 - 1 June 2023: Closure of open accounts without debt of the serious teams
