
SUPPLEMENTARY ELECTORAL REGULATIONS 2024

The Election Committee for the 2024 elections consist of:

- Wout Rubbrecht
- Yarne Billen
- Jack Pou
- Robbe Hollevoet
- Vincent Van den Moortel

They were elected as the Electoral Committee 2024 in the General Assembly on 1st of Decemeber 2023.

Furthermore, the following names are used:

- Industria for Student Association Industria vzw
- Fakbar for De Fakbar vzw (better known as *Recup*)

1. All official communications with the Neutral Committee should be by e-mail to kiescomite@industria.be or kc@industria.be.
2. Every team, both serious and fun teams, are forbidden to make deals in the name of Studentenvereniging Industria vzw, Industria vzw or Industria. It is also forbidden to make deals that affect our union in the short or long term.
3. Each serious team should keep open accounts, which should be closed by the next academic year at the latest, without debts. A margin of at least 10% of the total income should be kept, with a maximum of €1500 (THOUSAND FIVE HUNDRED EURO).
4. Each serious team should mention itself in all external communications as candidate praesidium. All communication should be in its own name, Kiesweek Industria, KU Leuven Campus Group T Leuven, Faculty of Engineering Technology KU Leuven, or KU Leuven may be mentioned if kc@industria.be is in BCC.
5. §1. A fun team is recognised by the Election Committee if they organise at least one activity approved by the Election Committee.
§2. Industria's maximum contribution per fun team will be determined based on the number of registrations on the registration deadline. This amount will be reimbursed before June 2, 2024
6. The fun team(s) will receive sponsorship if and only if they submit an account or a number of account to the Election Committee. The total amount of the account(s) must correspond to the amount made available by Industria, within a margin of €5 (FIVE EURO).
7. §1. It is strictly forbidden to contact companies before having received a list of "companies not to contact". This list must be requested by each team via an official mail to kc@industria.be.

§2. If a team nevertheless contacts a company that is on this list without the explicit, written consent of the Election Committee, the team may be forced to end its cooperation with this company.

8. Each meeting of a team (serious and fun team) within the buildings of KU Leuven Campus Group T must be announced to the Election Committee at least one day in advance. An emergency meeting cannot take place in the KU Leuven Campus Group T buildings.
9. Each team (serious and fun team) must keep an open accounting. This means that the accounts must be available for inspection by the Election Committee at all times.
10. Phoning with official KU Leuven Campus Group T telephones is strictly forbidden in rooms GT 01.4.01/1, GT 91.P1.13 and GT 92.P2.06. These are the Industria room, the Kursusdienst, the support room and its expansion respectively. Any other telephone calls with such devices must be reported to the Election Committee.
11. Serious teams should be present in full at the transfer cantus. All members of a serious team must come dressed as their spirit animal. Penalties may be imposed by Election Committee for any member not attending or not dressed correctly.
12. §1. A location request can be prepared by any serious team but must be submitted by the Election Committee. In the event of a conflict, the Election Committee will decide who will have priority. No further discussion will be possible on this.
13. §1. On activities of both serious teams and fun teams selling foods or drinks, the products are always first offered free of charge to the entire Election Committee. After approval of the Election Committee, the activity may proceed.
§2. Members of the Election Committee may participate in all activities organized by the team(s) free of charge.
14. Each team (serious and not serious) should provide an extra item of their textiles, this if the team provides textiles for its members. The extra item will be paid for by Election Committee and will serve for the archives of Industria.
15. Each member of each team (serious and non-serious) should introduce themselves to Gerda in Alma Group T. Failure to do so may result in the Election Committee imposing a play sanction on the team concerned.
16. Each team (serious and not serious) must fill the shifts, imposed by Election Committee, that come with the campaign day. If this is not done, Election Committee may impose sanctions.
17. Failure to meet a deadline will be punished by the Election Committee. The penalty will be decided by the Election Committee. Teams must respect the following deadlines:
 - 1st of February 2024: First registration of serious teams.
 - 1st March 2024: Second registration of serious teams.
 - 16 March 2024: Dates and locations for all activities of all teams.
 - 30 March 2024: Finished script for all activities of all teams.

- 1st of April 2024: Registration for fun teams.
- 7 April 2024: Application for disc IV for the serious teams.
- 14 April 2024: Application for discs II and III for the serious teams.
- 20 April 2024: Final list with members of the serious teams.
- 2nd of June 2024: Closure of open accounts without debt of the serious teams
